TO DETERMINE WHO SHOULD BE REGISTERED AS A DELEGATE, PLEASE USE GUIDELINE BELOW FROM GFWC VIRGINIA BYLAWS:

Section 7. Representation

- B. Representation at District meetings shall consist of:
1. Elected and appointed officers and Junior officers of the District;
 2. District Chairmen and District Junior Chairmen of Departments, Programs, Standing and Special Committees;
 3. Past Presidents of the District and Past Presidents of GFWC Virginia who are members of clubs in the District;
 4. Members of clubs in the District who are serving as GFWC Virginia officers, GFWC Virginia Chairmen, GFWC Virginia Junior officers and/or as a member of the GFWC Board of Directors;
 5. Presidents of city and county federations;
 6. Two delegates from each club, one of whom shall be the president or her alternate*; clubs with more than fifty members shall receive an additional delegate for each additional fifty members or major fraction thereof.**

*A club whose president is serving at a higher level has as its first delegate, the president's alternate.

**One (1) additional delegate for each additional 50 members or major fraction thereof:

1-75 = 2 delegates
76-125 = 3 delegates
126-175 = 4 delegates
176-225 = 5 delegates
